1	Chairman's Welcome IM thanked everyone for coming & conveyed his best wishes to Caz Sanigar	
5	Co-Founders Report The Charity delivered 2 projects in the year. A new project with the Kent Community Health Trust & a second project for Seaview. <ol style="list-style-type: none"> Seaview Project – AC highlighted key elements from the detailed report entitled <u>Seaview Evaluation & Data</u>. A copy of this report was sent to all Trustees (memo of 18th June 2018) & will be available on the website soon as part of a major update revision. A legacy of the 2 projects is Seaview's own commitment to self-funding continuing choirs. Kent Community Health NHS Trust – A 10-week trial course began in January at 2 venues: Ashford & Sevenoaks. A further 10-week course was requested with a concert given at the annual staff awards in June. A second concert was requested for the AGM to be held in September. These 2 venues are currently ongoing with a further course already paid from January 2019. The choir performed at a further concert in the summer & have a Christmas concert booked. There has been a small drop in numbers at the Ashford site owing to the distance the members have to travel. This is currently under review. KCH added a third location, Hastings, which began a 10-week trial in September. Between the 3 locations, currently there are 87 choir members & the scheme would appear to be ongoing. 	
6	Treasurer's Report <ol style="list-style-type: none"> The annual accounts were presented by DP. A copy of the report was distributed to Trustees Balance of funds, with no outstanding payments at year end, stands at £590 	
7	Election of Officers/Trustees <ol style="list-style-type: none"> SG elected as a new Trustee & will take over as Secretary from CS who remains a Trustee. This was proposed by IM, seconded by JB. SG will have no voting entitlement that could benefit MG. All existing Trustees were proposed & re-elected IM remains as Chair. Proposed by JB; seconded by TJ DP remains as Treasurer.
